Key Points Discussed:

Mr. Hisakawa presented the project summary for the basic survey on developing airport pavement standards with Japanese technical cooperation, including objectives, schedule, and methodology.

The study focuses on evaluating current conditions of airport pavement in Vietnam and introducing Japanese standards as a potential model for improvement.

Discussion on the necessity to build a comprehensive system of Vietnamese standards for airport pavement, as current standards issued by CAAV are not comprehensive.

Agreement on the importance of inviting representatives from the Ministry of Science and Technology to the Kick-off Meeting for the Development of Vietnam Standards for Airport Pavement on February 27, 2024.

Plans for Nippon Koei to conduct site surveys of various airports in Vietnam and the need for coordination with local airport authorities.

JCAB and CAAV agreed to communicate further on the draft invitation for the Kick-off Meeting for the Development of Vietnam Standards for Airport Pavement and other related documentation.

Action Items:

JCAB Responsibilities:

JCAB will prepare and send a comprehensive proposal as an official letter to CAAV regarding the Kick-off Meeting for the Development of Vietnam Standards for Airport Pavement and the organization of the survey, including a detailed schedule and a questionnaire.

CAAV Responsibilities:

- Arrange for site survey permissions for Nippon Koei in Vietnam, facilitating their on-ground activities.
- Provide contact information for airport staff relevant to the site surveys, ensuring effective coordination and communication.

 Provide answers to the questionnaire promptly for the survey's preparation, ensuring timely progress and resolution of inquiries.

Nippon Koei Responsibilities:

 Share Japanese airport pavement standards with CAAV, initially in Japanese and subsequently translated into English, for review and consideration in project planning.

Scheduled for February 27, 2024.
